#### **CATALOG DESCRIPTION**

The Doctoral Research Seminar in International Business enables students to engage in an in-depth study of current issues in the discipline that offers excellent opportunities for selection of topics for scholarly research and publication of findings. A variety of International business topics are explored from the standpoint of their conceptual framework and current practices. Specific issues are identified as areas where additional research-based information would be of significant benefit to professors and practitioners in terms of understanding and/or applying international specifics, tools, or analytical techniques. Research methodologies are presented and students are assigned focused research topics as a part of their course requirements. (3 units)

Prerequisites: Completion of all DBA core and at least four concentration courses. CR/NC

#### **COURSE DESCRIPTION**

The Doctoral Research Seminar in International Business provides doctoral students with an intensive examination of contemporary research topics in international business scholarship. Students will engage deeply with the international business literature, developing expertise in research design, methodological rigor, and theoretical frameworks that inform the field.

The course introduces students to a comprehensive range of international business research domains, including but not limited to global strategy, cross-cultural management, international entrepreneurship, foreign direct investment, multinational enterprise theory, global value chains, institutional theory applications, international trade policy, and emerging market dynamics. Through critical analysis of seminal and cutting-edge scholarship, students will identify research gaps where original inquiry could advance theoretical understanding or practical application within specific international business contexts.

Students will become proficient in the methodological tools and analytical techniques employed in international business research, including comparative case study methods, cross-national quantitative analysis, institutional analysis frameworks, and mixed-methods approaches

appropriate to complex global phenomena. Emphasis will be placed on developing research that is both theoretically rigorous and empirically grounded, with attention to the unique challenges of conducting research across national and cultural boundaries.

A central requirement of the course is the development of an independent research project. Students will select an international business topic of scholarly interest, design a comprehensive research plan following established academic conventions, and execute the project throughout the semester with ongoing mentorship from the instructor. Research projects must be completed by semester's end and require both a formal oral presentation to the seminar and submission of a complete written manuscript suitable for journal review.

#### **LEARNING OBJECTIVES**

The focus of this course is to further the student's ability to identify, structure and pursue scholarly research in a specific business area. Students completing this course are expected to have identified the topic and issues they wish to pursue for their dissertation research ensuring that they continue making steady progress toward the completion of all requirements of the DBA program. The research undertaken in this course should equip the student with International Businesses research tools and methodologies essential for continuing and broadening their identified dissertation research objectives, process and analysis of outcomes.

#### **METHODOLOGY**

#### GENERAL INSTRUCTIONS

At the beginning of the semester students will be presented with a number of current International Business topics, which offer opportunities for productive scholarly research. Students will be required to engage in a preliminary literature search to gather information on a topic of interest to them and to share with the instructor and class some of their initial research ideas. Topics selected by students will be explored in more detail during class sessions for the purpose of helping the student clarify and define the structure and content of their selected research topic and research objectives.

Students will then be required to develop and submit their research plan for instructor approval. Once approved students are to begin their research. Completion of this course requires students to provide both an oral and written presentation of their research project.

#### RESEARCH ASSIGNMENTS

Assignments and projects require students to actively use resources of the library. Detailed guide to business *resources of the library* as well as the description of Lincoln University approach to *information literacy* are available at the <u>LU Library</u> website (lincolnuca.libguides.com).

Students will receive a listing of current International Business topics containing issues that would benefit from scholarly research. Students are to engage in an initial literature search on these topics with the intent of identifying a research topic of interest to them and be prepared to discuss the results of their literature search in class.

After class discussion and further exploration of student research area interests, each student is to develop and submit a research plan for instructor approval. Once approved, students are to undertake their chosen research area.

Students are required to provide both an oral and a written research report explaining their research selection, hypothesis or problem statement, research methodology, data analysis and findings, and summary and conclusions. Oral presentations will be scheduled for the end of the semester and attendance is required by all class members. Written research reports are due at the last class meeting.

#### **STANDARDS**

Students are expected to attend each class meeting and be prepared to discuss all research related assignment in class. Students who come to class late will not be admitted until the break period. Every member of the class is expected to participate in discussions surrounding the assignments. There is no eating or drinking in class and the use of cell phones or laptops is only permitted if

related to class assignments.

#### RESEARCH PROJECT

Student research projects are required to be turned in correct written form using the Lincoln University standard format established for such documents. Copies of the University format requirement will be handed out in class or can be obtained from the University web site.

Student oral presentations are expected to be professionally presented to the class and instructor including the use of electronically based media for display of the presentation content including slides, graphs, tables and charts.

Both the written research report and oral presentation are due on TBD.
